

- Mr. Vivek Mehra (DIN: 00101328) and Mr. Sasha Mirchandani (DIN: 01179921) ceased to be Non-Executive Independent Directors of the Company with effect from December 24, 2023;
- Mr. Uttam Prakash Agarwal (DIN: 00272983), Mr. Shishir Babubhai Desai (DIN: 01453410) and Dr. Venkata Ramana Murthy Pinisetti (DIN: 03483544) were appointed as an Additional Director (Non-Executive Independent Directors) of the Company, with effect from December 17, 2023 for the first term of 3 years, and thereafter, regularised through postal ballot notice dated February 05, 2024.

- 13. Appointment/re-appointment/filing up casual vacancies of auditors as per the provisions of section 139 of the Act:
 - There was no instance of appointment/re-appointment/filing up of casual vacancy of auditor during the period under review.

Further, on June 24, 2024, the NCLT allowed the application filed by the Company to withdraw its application seeking implementation of the Scheme with liberty to the Parties to pursue their respective remedies as and when warranted and in accordance with law. Finally, on August 29, 2024, the Company filed an application before the NCLT seeking recall of the sanction order dated August 10, 2023, and withdrawal of the Scheme and on September 5, 2024, the NCLT passed an order allowing the withdrawal of the Scheme and recalling the order dated August 10, 2023 by which the Scheme was sanctioned.
 - There were no instances requiring approvals from the Central Government, Regional Director, Registrar, Court or such other authorities during the period under review;
